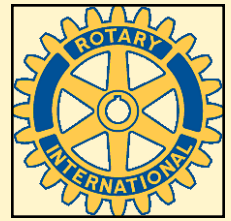

October 31 — Dr. Amy Carey, President, Friends University

Topic: *A Vision for a Thriving University in an Uncertain Higher Education Landscape*

Dr. Amy Bragg Carey was selected by the board of trustees as president of Friends University in March of 2015 and began her role on July 1st. She comes to the university from Saint Paul, Minnesota, where she had served as the vice president of institutional advancement for the University of Northwestern since 2003. As vice president she led in the area of advancement for the university and media division. Her prior responsibilities at the University of Northwestern included oversight in the areas of marketing and communications, alumni and parent relations, admissions and financial aid.

Dr. Carey's prior professional experience includes four years (1999-2003) with Minnehaha Academy in Minneapolis, as director of development. Additionally, she spent 13 years with the HealthEast Foundation of Saint Paul. Dr. Carey served on the national standards committee for the ECFA (Evangelical Council for Financial Accountability) and is past chair of the Chief Institutional Advancement Officers Commission for the CCCU (Coalition for Christian Colleges and Universities). She is past president of the Minnesota Planned Giving Council, a professional development association, and has served on a number of community and non-profit boards.

Dr. Carey holds an Ed.D from Azusa Pacific University in higher education leadership, a M.A. degree in philanthropy and development from St. Mary's University in Winona, Minnesota and an undergraduate degree in communications from Bethel University in Minnesota.

Anna is a 2013 graduate of the University of Northwestern and Brett is in his senior year there. Koch Ag & Energy Solutions, LLC and its affiliates are a global provider of value-added solutions for the agriculture, turf and ornamental, energy and chemical markets.
